WAIVER AND INDEMNITY

By participating in any activities organised, facilitated, supported or permitted by Glen Waverley Bowls Club Inc. ("Club"), all participants including members, non-members, guests, visitors, junior participants and spectators (collectively referred to as "Participants") hereby acknowledge and agree to be bound by the terms of this Waiver and Indemnity. Participation is also subject to the Club's Constitution and By-Laws, which are incorporated by reference and available on the Club's website.

Definition of Club activities

For the purpose of this Waiver and Indemnity, Club activities include, but are not limited to, lawn bowls, indoor bowls, pickleball, coaching, practice sessions, training, social and community events, fundraising events, and any other sporting or recreational activities whatsoever, whether held on or off Club premises, provided such activities are organised, facilitated, supported or permitted by the Club.

Assumption of Risk

Participation in Club activities carries inherent risks, including but not limited to injury, illness, death and/or damage to personal property. All Participants accept and assume full responsibility for these risks and for ensuring they are physically and medically fit to participate. The Club does not provide medical advice or fitness assessments to any Participants.

Waiver of Liability

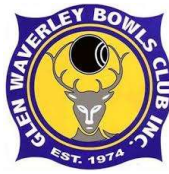
To the fullest extent permitted by law, Participants release, waive and hold harmless the Club and its directors, members, volunteers, staff, agents, and representatives from any and all liability for injuries, deaths, illnesses, losses, claims, damages, costs, charges or expenses of any kind, or for any other harm Participants may suffer, including those arising from the negligence of the Club or its representatives, or from any loss of or damage to personal property, arising from participation in Club activities or use of Club premises and facilities.

Indemnity

Participants agree to indemnify and hold harmless the Club and its directors, members, volunteers, staff, agents, and representatives from and against any and all losses, claims, liabilities, demands, actions, damages, costs, charges and expenses arising out of or resulting from their participation in Club activities or use of Club premises and facilities.

Junior Participants

Participants under 18 years of age must have parental or guardian consent to take part in Club activities. Parents or guardians accept all terms of this Waiver and Indemnity on behalf of the junior participants and are responsible for their conduct, supervision and wellbeing while participating in any Club activities or use of Club premises and facilities. Visitors under the age of 18 must be accompanied by a responsible adult.

Guests and Non-Members

All guests, visitors and non-member Participants are subject to this Waiver and Indemnity and must comply with Club rules. The inviting member or organiser is responsible for informing them of these terms and ensuring they understand and accept them prior to participating in any Club activities or using Club premises and facilities.

Medical Emergencies

The Club does not provide medical or emergency services. Participants are fully responsible for their own medical needs and the use of any medical or first aid equipment on Club premises. In the event of a medical emergency, the Club may, at its discretion, seek assistance for Participants, including medical treatment or ambulance services. Any related costs shall be borne entirely by the Participants. This Waiver and Indemnity also extends to anyone who acts in good faith to provide emergency assistance.

Media Consent

The Participants consent to the use of photographs or video taken during Club activities for promotional or informational purposes including social media, website, newsletters and other Club-related materials, unless the Club receives written notice of objection.

Modifications

The Club may, from time to time, review and update the terms of this Waiver and Indemnity. Updated terms will be posted on the Club's website and will take immediate effect. Continued participation in Club activities after such updates constitutes acceptance of the revised terms.

Review:

This policy shall be reviewed every two years or as required by change of legislation or Club circumstances. Amendments will be communicated to all members and staff.
